

## RULES 2015 DIVINICOLLI

### Organization: Fondazione Valdobbiadene Spumante

Fondazione Valdobbiadene Spumante organizes for **Sunday 7th June 2015** the 2<sup>nd</sup> edition of DiviniColli in Valdobbiadene (Treviso), Italy.

#### **Art. 1 PARTICIPATION REQUIREMENTS**

Participants of both gender can participate, according to the prearranged set of forms; underage kids can participate only if accompanied by a parent or by an adult participant.

It is allowed to participate only by foot or by other means without motor (racing bike, mountain bike); every form of competitiveness is prohibited.

If the underage kid is not under the supervision of one of the parents, the adult accompanying the kid will have to exclusively and in person watch him before, during and after the manifestation.

#### **Art. 2 FURTHER OBLIGATIONS REGARDING THE PARTICIPATION FORM**

**comma 1.** By signing the participation form or by paying the participation fee every participant bounds himself to respecting the Regulation, as well as keeping a well-mannered and cautious behavior during the manifestation.

**comma 2.** By signing the participation form or by paying the participation fee every participant declares and confirms:

**a)** To be in physical conditions fit to participate to the manifestation and to free and release the Organization from liability and from responsibility;

**b)** If accompanying an underage kid not under the direct responsibility of a participating parent, to keep watch on him before, during and after the manifestation;

**c)** To authorize the organization to process personal and sensitive data which are strictly inherent to the participation including, for underage kids, the personal data of who exercises parental authority;

**d)** To expressly authorize the organization to use still and/or shifting pictures which portrait the participant during DiviniColli 2015 for free, without territorial limits and taken with all devices, for promotional and/or marketing and/or archive and/or documentation purposes, and without demanding any remuneration for the utilization right of these pictures, including any related right;

**e)** To be aware that the organization is not responsible for eventual dangers deriving from participating to the event and for eventual acts of vandalism, thefts and prejudicial events of any kind to which participants could be subjected by anyone at any stage of the manifestation, being the custody of whichever object (thing) responsibility of each single participant;

**f)** To free therefore the organization, the voluntaries and all personnel employed by the organization from any responsibility, without exceptions, for any damage which takes place during the event as direct and/or indirect consequence of declarations, facts, circumstances, or physical states or conditions ascribable to a violation of the present Regulation committed independently and/or by other participants;

**g)** To accept the unquestionable judgment of not admission, exclusion, formulated by the organization for those cases contemplated in the Regulation.

#### **Art. 3 CONDITIONS - PARTICIPATION TERMS AND PROCEDURE:**

**comma 1.** Subscriptions open on Monday 20<sup>th</sup> April 2014 and close on Sunday 7<sup>th</sup> June 2015 at 10:00 am with maximum number of 1300 participants.

**comma 2.** The participation form is available on the website [www.divinicolli.it](http://www.divinicolli.it); it must be filled in and sent together with a receipt of bank transfer payment per e-mail to the address [info@divinicolli.it](mailto:info@divinicolli.it) or per Fax at +0039 0423 976975. The participation form can also be delivered in person at the Tourist Information Office of Valdobbiadene (Palazzo C. Piva, Via Piva n.53; timetable MON-SAT: 9:30 – 12:30 and 15:00 – 18:00). In this case you will receive a receipt of payment to testify the subscription.

**comma 3.** Secretary personnel will remain to your disposal for any further information at office hours at the phone number: +0039 0423 976975.

**comma 4.** If you eventually want to verify that the subscription was successfully registered, please send an e-mail to: [info@divinicolli.it](mailto:info@divinicolli.it). Subscriptions have to be sent within the notified deadline.

**comma 5.** The organization has the authority, at its own unquestionable discretion, not to admit participants who didn't fill in the registration form. In this case, paid participation fees will be refund.

**Art. 6 MEETING – MEETING AND STARTING**

**comma 1.** Meeting is planned for Sunday 8<sup>th</sup> June in the morning, within 09.30 in Piazza Guglielmo Marconi, Valdobbiadene.

**comma 2.** Participants must present the receipt of payment to receive the badge and participation pectoral and for eventual verifications by the organization.

**comma 3.** After 10.00 a.m. of Sunday 8<sup>th</sup> June 2014 no further subscriptions will be accepted; starting is allowed until 11.00 after the official starting clearance.

**comma 4.** In case of underage kids, accompanying participants have to present themselves together with the kid they will accompany.

**comma 5.** The participation badge is strictly personal and can't be given to third parties.

**comma 6.** The back of the participation badge can be filled with indications of the telephone number to contact in case of accident and/or eventual medical information to declare, so that in case of health problems physicians can manage better the emergency.

**Art. 7 STARTING – TRACK AND SCHEDULE - ARRIVAL**

Meeting within 09.30;

There will be 3 itineraries: the participants have to decide how long they want walk on the registration form.

Every change from the organization will be communicate by e-mail at the e –mail address wrote on the registration form.

The start is in Valdobbiadene, Piazza Guglielmo Marconi.

First start: 10:00 am run by bike (20 km), horses, others no motor vehicle, long walked by feet (14 km);

Second start: 10:30 am short walked by feet (8 km);

Third start: 11:00 am short walked by feet (8 km).

The final stage and arrival point are in Villa dei Cedri, Valdobbiadene, in via Piva, 89

#### **Art. 8 TRAFFIC LAWS AND FURTHER BEHAVIOUR ROULES**

**comma 1.** It is compulsory to wear the identification pectoral until the end of the manifestation.

**comma 2.** For bikers, it is compulsory to wear the homologated protective helmet.

**comma 3.** Participants must also respect the environment and must not leave garbage along the road, it must be thrown in apposite containers at the refreshment points. Participants who do not respect the environment and/or throw garbage out of the apposite spaces and/or do not hold a correct and/or civil behavior during the manifestation may be penalized.

**comma 4.** To grant the best success of the manifestation, it is forbidden the use private means or to receive assistance from them during the event under penalty of immediate expulsion of the participant from the manifestation.

**comma 5.** The organization provides means of transport to collect and take all participants who for any reason cannot finish the track to the arrival point.

**comma 6.** Roads covered by participants will not be closed to traffic during the manifestation, therefore participants have to pay attention to rules of the road and follow common rules of caution and attention.

#### **Art. 9 HEALTH SERVICE**

**comma 1.** Health service is provided in Piazza Guglielmo Marconi, Valdobbiadene.

**comma 2.** In no case is the organization responsible for any action and/or decision taken by health service personnel.

#### **Art. 10 ANNULMENT OF THE MANIFESTATION**

**comma 1.** In case of bad weather the manifestation will take place anyway.

**comma 2.** The organization won't refund any subscription, but it will hold it valid as participation fee for the 2016 edition.

#### **Art. 11 COMPLAINTS**

**comma 2.** In case of attested complaint, the organization will wholly refund the paid fee.

**comma 4.** The person concerned has also the right to oppose, completely or partially, for legitimate reasons, the processing of his personal data even if pertinent for the purpose of the collection.
